Legal Advocacy and Resource Center (LARC)

LARC runs a hotline for low-income Massachusetts residents with legal problems, answering questions about legal rights and eligibility for free legal representation from legal service agencies in Massachusetts. The LARC hotline also provides referrals to appropriate free legal services, private bar panels who may be able to handle cases for a fee, and appropriate social services and government agencies. The LARC focuses on cases involving housing, family law, public benefits, employment issues, consumer issues, CORI issues, and veterans; and restricts services for low income individuals (less than 300% of the Federal Poverty Income Guidelines) and individuals who are 60 years old or older. The WilmerHale Legal Services Center

The Legal Services Center is a neighborhood law office in Jamaica Plain and a Harvard Law School clinical teaching facility. The Center assigns law students to handle your case at a below market rate under the direct supervision and guidance of an attorney or paralegal. The Center provides legal assistance regarding disability benefits, estate and permanency planning, consumer law, family law, government benefits, and housing law; and has a Spanish interpreter and access to other language interpreters for in-office case assistance.

The Center provides legal representation on a reduced fee basis to Suffolk County residents with gross annual incomes below about 300% of federal poverty income guidelines. People with gross annual incomes and assets below 187% are not typically charged a fee for the services. Unless waived by a court, you are responsible for all case costs including court fees, subpoenas, service of process, housing inspections, depositions, expert witness fees and evaluations.

CIVIL RIGHTS

Massachusetts Commission Against Discrimination (MCAD)

MCAD is the state's chief civil rights agency. The Commission works to eliminate discrimination on a variety of bases and areas, and strives to advance the civil rights of the people of the Commonwealth through law enforcement, outreach, and training. Gay, lesbian, bisexual, transgender and HIV+ people are protected classes. If you believe you have been discriminated against, you should file a complaint immediately. MCAD cannot accept complaints based on incidents over 300 days old. Offices are in Boston, Springfield, Worcester, and New Bedford. (NOTE: In cases of employment discrimination, the Fair Employment Project, 617-390-2593, may be able to assist you in putting together your complaint to MCAD).

American Civil Liberties Union of Massachusetts (ACLUM)

Attorney General's Office (AGO) Civil Rights Division

The Division provides information; accepts and reviews complaints alleging violations of civil rights; brings enforcement actions under state and federal laws that prohibit discrimination; enforces the Massachusetts Civil Rights Act by obtaining civil rights injunctions to protect victims of bias-motivated

threats, intimidation, coercion and violence; files amicus briefs in civil rights cases; and prosecutes housing discrimination cases when the Massachusetts Commission Against Discrimination has made a finding of probable cause of discrimination and the case has been removed to Superior Court. The AGO does not provide legal representation for individuals. For individual legal representation, contact the Massachusetts Bar Association or Massachusetts Legal Services (information above).

If you believe you have suffered from a hate crime, you should immediately contact your local police department and [file a civil rights complaint](#) with the AGO.

The Gay Men's Domestic Violence Project (GMDVP)

The Law Center maintains a statewide phone helpline through which it provides information and referrals regarding legal matters that impact children. Bilingual assistance is available. Issues routinely addressed include children who do not receive the education services to which they are entitled under federal and state law; emancipation; immigration; rights of children who have "aged out" of foster care or other state human service systems; and, collateral consequences of juvenile court involvement.
