The Legal Advice and Referral Center (LARC) is staffed by attorneys and paralegals who provide free information, legal advice, and referral services to low-income persons in the areas of family law, consumer law, bankruptcy, public benefits, and housing. Clients should be made aware that LARC does intakes on weekdays from 9:00am until 1:00pm and it is best to call as close to 9:00 as possible. For the rest of the callers, referrals are made and short term interventions are done. It only does work for people who live and/or work in New Hampshire.

The New Hampshire Coalition Against Domestic and Sexual Violence is a statewide network of independent member programs committed to ending domestic and sexual violence. To that end we seek to: ensure that quality services are provided to victims/survivors of domestic and sexual violence; prevent future violence by educating the public; influence public policy; and encourage the provision of services for perpetrators. The N.H. Coalition is comprised of 14 independent programs throughout the state that provide services to survivors of sexual assault and domestic violence. Their services are free, confidential, and available to all victims. The services include: emergency shelter and transportation; legal advocacy in obtaining restraining orders against abusers; hospital, police, and court accompaniment; information about and help in obtaining public assistance.
